SME Employment Scheme for Registered SMEs *(Sole Trader/Company/Cooperative, excluding pure Trading activities)*

The SME Employment Scheme, announced in the Budget Speech 2018-2019, seeks to instill and develop entrepreneurial skills among graduates, and boost their employability while providing SMEs with an injection of fresh talents to support their development.

1. Invitation to apply

SME Mauritius Ltd is inviting applications from **registered SMEs** who wish to recruit graduates for placement in their respective enterprises under the SME Employment Scheme for a period of one year, which may be renewed for a further period of one year.

2. Eligibility

The Employer should

- be duly registered with the SME Registration Unit;
- be in operation for at least six months;
- ensure that the graduate works under supervision;
- be willing to sign an agreement with SME Mauritius Ltd.

3. Stipend

SME Mauritius Ltd will pay a monthly stipend of Rs 14,000 to the selected graduate, while the Employer will have to pay the monthly travelling costs.

The provisions regarding payment of NSF and NPF will not apply in respect of graduates participating in the SME Employment Scheme.

4. Monitoring

It is the Employer's responsibility to report on the attendance of the graduate.

SME Mauritius will also monitor the progress of the graduates.
